Miriam is a habitat homeowner of 16 years. She raised her four children alone for many years. She grew up in Spanish Harlem in NY where her mother was her rock and provided a stable, loving home. She was the youngest of four and had many friends. She never thought she would leave NY until her best friend Shari-Lyn did. After the birth of her fourth child, she followed her friend to Georgia.

Miriam's relationship with her husband was not strong at the time, so he stayed in NY and Miriam with her four young children into an apartment in Sandy Springs. She started working immediately as a bilingual customer service representative and one of her co-workers, who was a Habitat homeowner, urged her to apply. While Miriam was not approved initially, she was counseled to improve her credit by making a few changes, so she could qualify. As instructed, she moved into a more affordable, 2-bedroom apartment. Miriam slept in the dining room so her children could have bedrooms. They lived there until she was able to qualify for Habitat's homebuyer program the next year. Miriam and her kids moved into the home and eventually her husband joined them after working through some differences. It was the stability of the home Miriam's mother provided that allowed her to stay motivated throughout the process. Miriam strives to keep her children safe and show them the same stability her mother had provided growing up. Recently, Miriam's eldest daughter told her that she never knew they struggled.

Gratitude is how Miriam starts every day. The strength of her mother and the stability of her home will continue with generations to come.

Octavia grew up in Alpharetta, and I loved it. It's where she had her first kiss, her first job, prom, church; It was home and all she knew. She found herself as a single mother moving from apartment to apartment every year trying to stay with in her means. It wasn't easy, living out of boxes, working 2 jobs and trying to finish high school. She struggled with the shame of being a young mom. She held close to her faith, knowing and believing God would provide. In 2007, she attended an application meeting for Habitat- NCG. She remembers, now a dear friend of hers was sitting in the pew in front of her helping me understand everything the representative was saying. She was so eager to turn my application in, and didn't let a week go by. She emptied out my savings account to pay the then \$1000 earnest money. She was approved and the build began.

Octavia went out every day after work, to walk around the circle 7 times, looking at the progress and dreaming of one day walking in the door and laying her keys on the table. She worked hard, alongside my extended family, friends, church family and volunteers.

She was 22 years old, the youngest Habitat-NCG recipient in history, when she finally turned the key to her first home. Home! A house she helped to build. She wrote on the wood that has held the walls up for now 17 years. She finished college and pranced up and down the street in my cap & gown. Her heart screaming, "I did it!"

She now has her 3rd degree. Her daughter, Ni'Oni, graduated college last year, and her son, Sean, is on his way to Mercer University this fall. She now serves on a community board for the city of Milton and has opened her own business serving the community.

Dreams look different these days. Having a stable home, a community and a little support to become independent can make big changes, breathing hope in the hopeless.



INDEPENDENT AUDITOR'S REPORT

To the Board of Directors Habitat for Humanity-North Central Georgia, Inc. Roswell, Georgia

Opinion

We have audited the accompanying financial statements of Habitat for Humanity-North Central Georgia, Inc. (a nonprofit organization), which comprise the statement of financial position as of June 30, 2022, and the related statements of activities, functional expenses, and cash flows for the year then ended, and the related notes to the financial statement s.

In our opinion, the financial statements referred to above present fairly,in all material respects, the financial position of Habitat for Humanity-North Central Georgia, Inc. as of June 30, 2022, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standard s generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements sect ion of our report. We are required to be independent of Habitat for Humanity-North Central Georgia, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Habitat for Humanity-North Central Georgia, Inc.'s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's repott that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraudor error, and design and perform audit procedures
 responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for
 the purpose of expressing an opinion on the effectiveness of Habitat for Humanity-North Central Georgia, Inc.'s internal control. Accordingly, no such opinion
 is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Habitat for Humanity-North Central Georgia, Inc.'s ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and cettain internal control related matters that we identified during the audit.

Report on Summarized Comparative Information

We have previously audited Habitat for Humanity-North Central Georgia, Inc.'s 2021 financial statements, and we expressed an unmodified audit opinion on those audited financial statements in our report dated October 18, 2021. In our opinion, the summarized comparative information presented herein as of and for the year ended June 30, 2021, is consistent, in all material respects, with the audited financial statements from which it has been derived.
